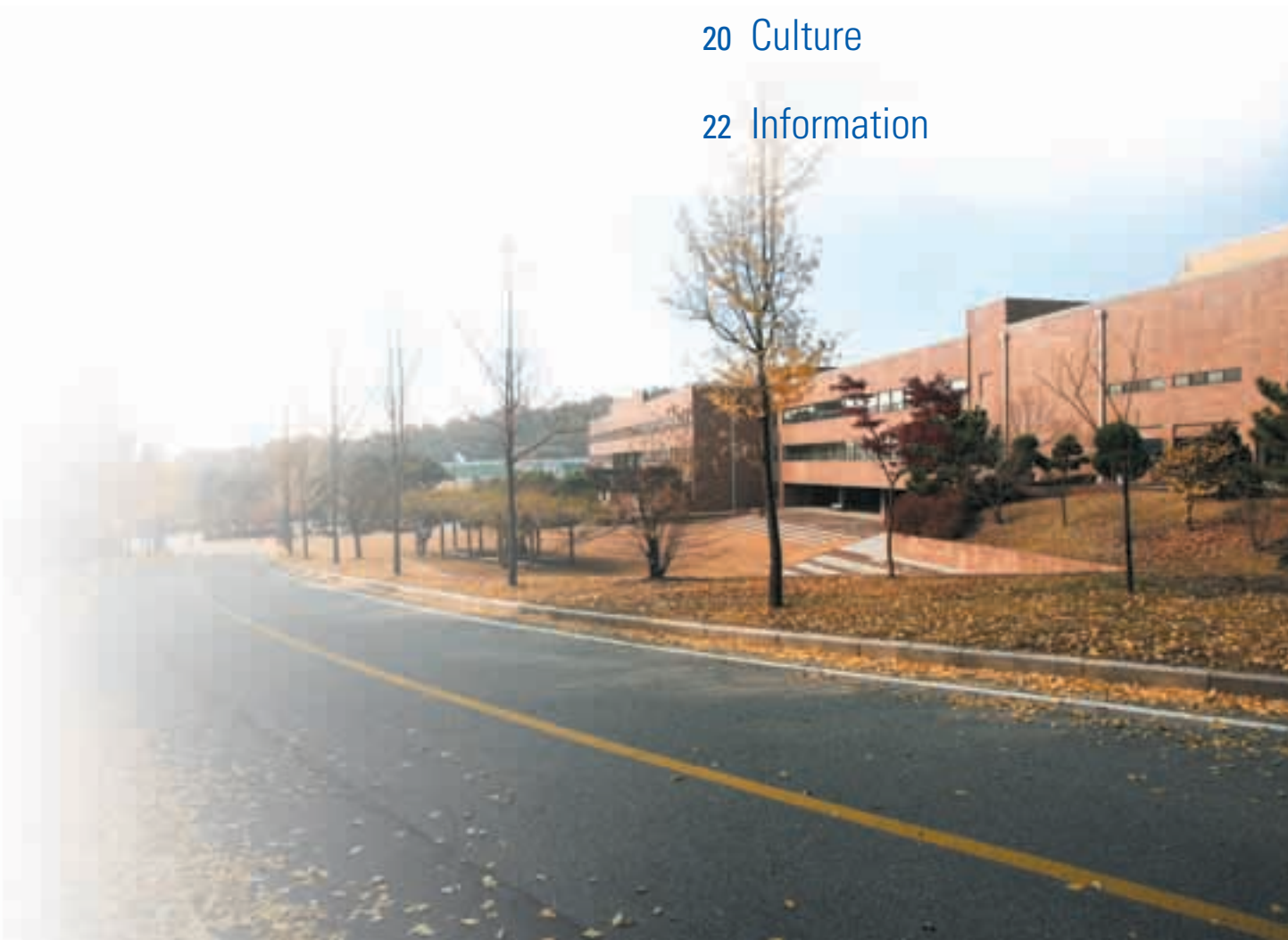

# History



- 1972. Established the Legal Research & Training Institute, Merged the correctional officer school \*  
Organized as the president, vice president, administrative division, professor department, and research department  
Undertaking of the education for the entire public officials of the Ministry of Justice including the public prosecutors  
Inaugurated the Chief Prosecutor Yun, Du-Sik as the first president of the Legal Research & Training Institute
- 1981. Abrogated the deputy president and reorganized the professor department to the prosecutors' training department and the correctional training department
- 1983. Reorganized the prosecutors' training department to the general training department and established the research fellows system at the research department
- 1985. Established the institute statement (A lofty Ideal, Fruitful Training, Powerful Advance) / Produced the institute flag
- 1986. Moved the Department of Correctional Training to the new government office in Yongin  
Reorganized the research department to the Department of Planning, and established the research commissioner system
- 1988. Moved the main office of the Legal Research & Training Institute to the new government office in Yongin
- 1999. Integrated the planning department and the general training department and reorganized them into the Department of Planning  
(3 departments 5 divisions → 2 departments 5 divisions)
- 2007. Opened the 'e-Learning' Center
- 2012. Legal Research & Training Institute, scheduled to move to Jincheon, Eumseong, Chungbuk

\* The prison officer school was originally established in 1951, exclusively responsible for training the correctional officers. It was renamed 'Correctional Officer School' in 1962, conducting the joint education for the general public officials under the Ministry of Justice.

### ■ Integrated Education for General Service Officials

- A total of 64 courses
- Abolished the integrated education courses for the sixth to ninth-rank officials and systemize them into the education for each rank, basic, and advanced courses.

### ■ Strengthen the training through the basic education for the newly-appointed officials

- The newly-appointed officials at the fifth to seventh-rank general service officials in the prosecutors' office are included in the training courses for the ninth-rank new officials of each field and for those who have been promoted.

### ■ Education Renovation for General Service Officials

- Utilize the education methods suitable for each course's characteristics(e.g., lecture-type, experience training-type, participating-type, case study-type etc.)

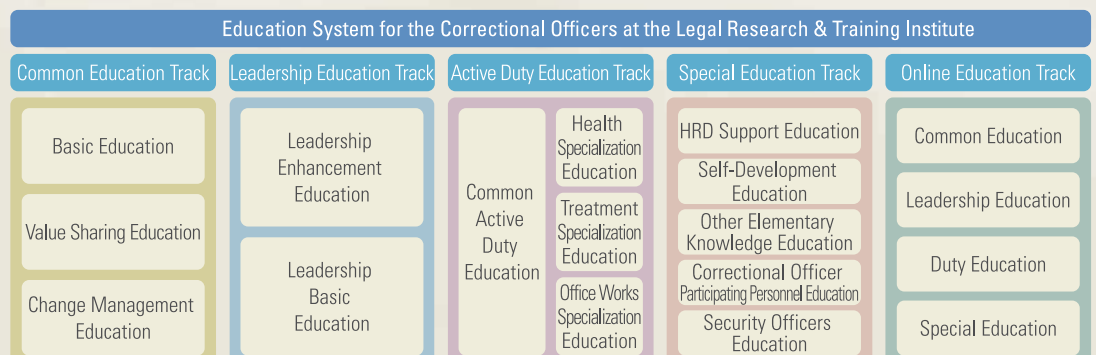

### ■ Prosecutors' 'e-Learning' Education Introduction

- Transferred the prosecutors' duties and actual investigation to 'e-learning' form → Completed with 174 subjects under 23 courses.
- Professional education courses(Economic Crime/Public Security Crime/Serious Crime/Environmenal Crime/Digital Crime) → Transfer to 'e-learning' form that provides the real-time education required for carrying out the duties.
- Introduce the authoring tool for the online education contents → Self-produce the education contents by directly recording and taping the lectures with the use of PPT teaching material.
- Convenient System for the Students
  - Remote support service by the Legal Research & Training Institute → It is a service that the operator helps the student to solve any errors swiftly while watching the student's computer screens with no additional installation of any programs.
  - SMS messaging service → Various information including the class information, assignment submission, lecture registration approval, completed courses, member registration etc. are being sent real-time through SMS messaging service for the students' convenience.

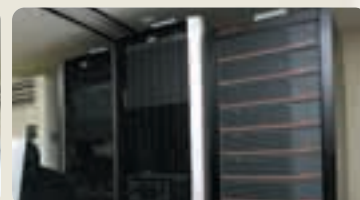
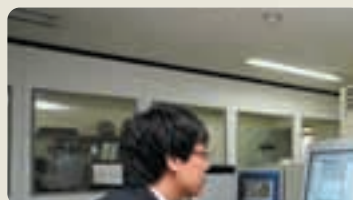

- Promote the friendly image of Korea through the industrial sites visits and cultural experiences





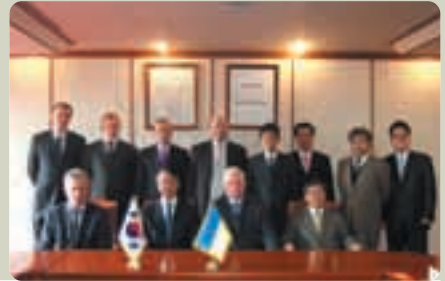

# Research

## Professional Research Activities by the Legal Research & Training Institute

### ■ Research Status

- Since the foundation of the Research Department in 1972(revised to the research commissioner system from 1986), the Institute has issued and published 269 theses including the study on the M&A legislation and 72 research volumes.
- Embarked on the research outsourcing for the mid- and long-term growth of the Institute.
- Research on the follow-up measures after the introduction of law school system and on the matters related with the changing locations of the Institute.

### ■ Research Activities

- **Publish the white paper on crimes**
  - Since 1984, nearly 1,100 copies are published on a yearly basis(in Korean) and distributed to the related organizations.
- **Publish the research thesis volumes on International Workshop**
  - Published a total of 22 thesis volumes from 1977 to 2006 that contain 340 pieces of excellent theses by the prosecutors who completed the international workshop.
  - From 2007, the thesis review and the volume publication had been transferred to the Supreme Prosecutors' Office.
- **Publish the thesis volume on the correctional research**
  - Published the third edition in 2007.
  - Produce nearly 200 copies annually and distribute them to the Ministry of Justice etc.
  - Participate in the correctional officers' research group(research club by the correctional officers)

- Distribute the white papers and thesis volumes to the related organizations.

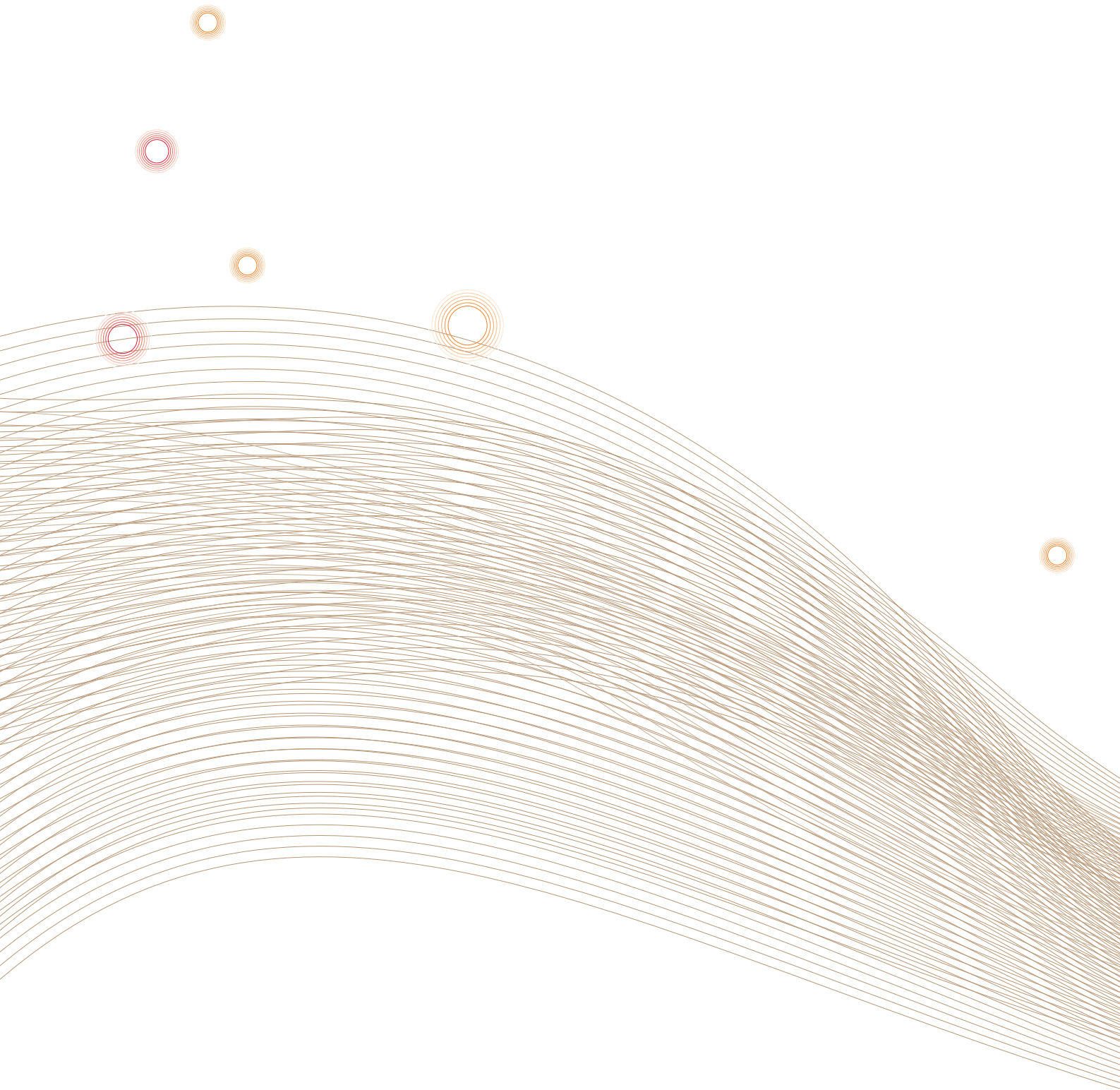
