The Institute of Justice (IOJ) is the integrated educational and research organization of the Republic of Korea that provides education and training for public officials assigned to the Ministry of Justice in the Republic of Korea. The Ministry of Justice is responsible for the administration of several law enforcement agencies such as the Supreme Prosecutor's Office, Probation Department, the Department of Prison and Corrections, and Immigration. The Institute of Justice is also entrusted with the educational training of legal affairs so that research reports as well as white papers on crimes are published on an annual basis and distributed to the related organizations.

The Institute of Justice strives to cultivate the talents and abilities of top-notch public officials in legal affairs so that they can perform their administrative responsibilities and tasks in a creative and proactive manner in this current knowledge and information era. Through in-depth educational training and research, the Institute of Justice pursues excellence in its contributions in the development of legal affairs in the Republic of Korea and to the global community.

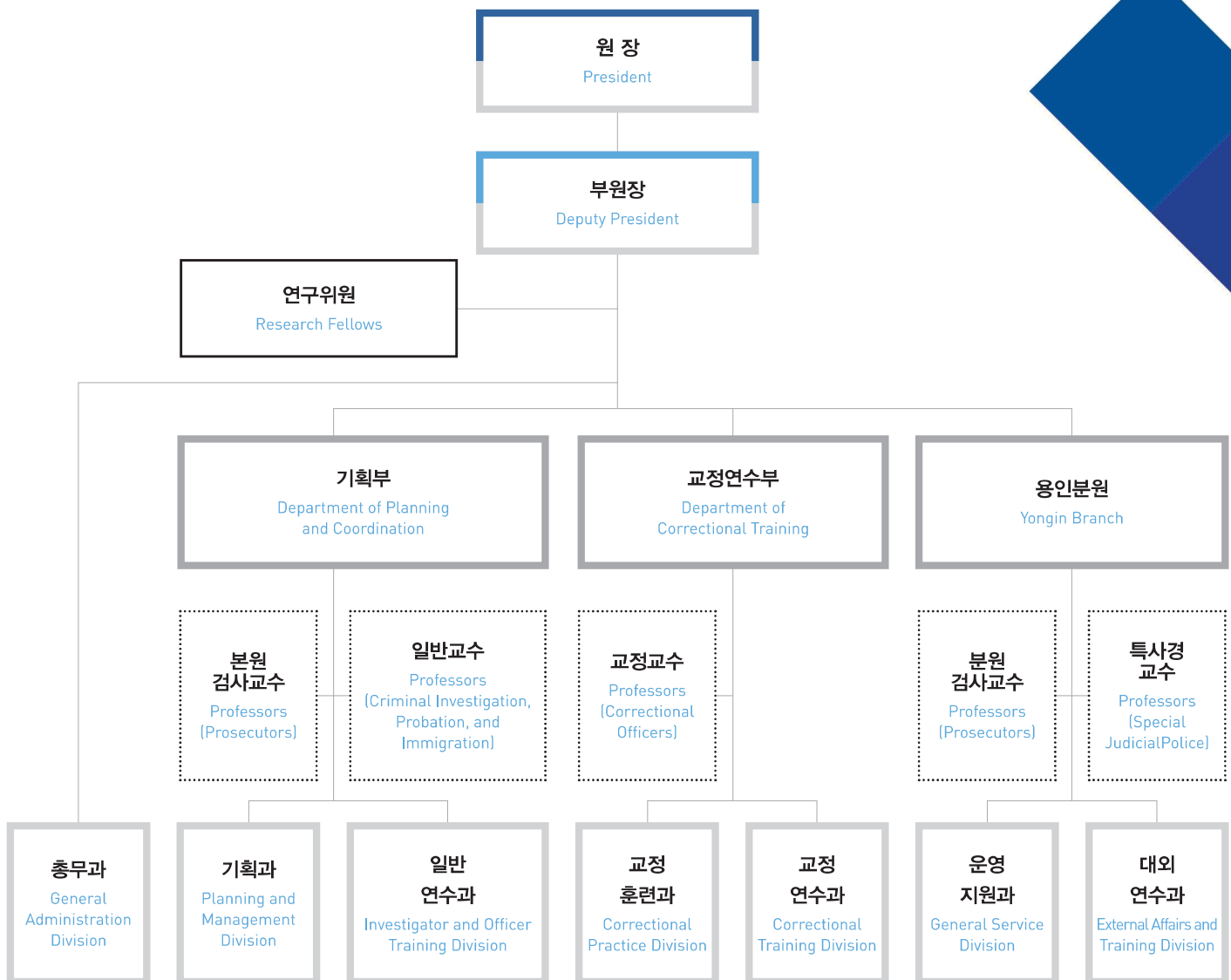

Over 31,000 Korean legal professionals and prosecutors who possess a high degree of
professionalism, intelligence and compassion attend the Institute of Justice annually.

The Institute of Justice was founded in 1951 as an innovative educational community. It first
began with the establishment of a school for prison officers so that these correctional officers
would be trained effectively. In 1972, the Republic of Korea expanded educational training
so that all civil servants involved in legal matters would receive instruction and guidance to
improve legal services to its citizens. The Institute of Justice has grown significantly since
then as the education and training institute for the public servants. The Institute of Justice has
secured its prominent position as the premier educational and training institute for the Ministry
of Justice.

The Institute of Justice has changed throughout the years with the passing of time in many ways
but it has remained constant in its vision and mission to educate and train the very best legal
personnel who establish law and order in Korea.

by the times!

TRAINING FOR PROSECUTORS

검사교육은 정의, 공정, 인권, 청렴 등 검찰의 핵심가치를 구체화시키기 위해, 「필수 기본역량 교육」, 「전문화」 및 「국가관 · 공직관 교육」 강화에 중점을 두고 있습니다.

「필수 기본역량 교육」은 신입검사, 경력검사, 부장검사, 지청장, 차장검사, 검사장 과정 등 6단계로 나누어 역량과 리더십을 함양하는 데 역점을 두고 있고, 특별수사전문가 과정 등 13개 「전문가 과정」을 운영하고 있습니다.

「국가관 · 공직관 교육」은 공직자로서의 올바른 자세 확립을 위해 '헌법관', '역사관', '안보관', '검사의 사명과 자세' 등 교육을 실시하고 있습니다.

To actualize the Republic of Korea's Prosecution Service's core values of Justice, Fairness, Human Rights, and Integrity, the Institute of Justice emphasizes the fundamental components of prosecutorial education. The Institute of Justice developed curriculum that reinforces key elements of what it means to be a prosecutor. Courses such as "Leadership for Each Stage of a Prosecutor's Career" cultivates leaders for each stage of a prosecutor's tenure. Prosecutors are classified as follows: Chief Prosecutor, Deputy Chief Prosecutor, Senior Prosecutor, Director of Branch Office, Career Prosecutor, and Newly-Appointed Prosecutor.

The Institute of Justice also runs 13 Professional Skills Courses. Some of these courses such as Special Investigations, Government Ethics, Public Office and Ethics provides instruction on prosecutorial conduct. Other classes such as Constitutional Law, Legal History of Korea, National Security Laws, and Prosecutorial Mission and Conduct also provide further instruction and guidance to Korean prosecutors.

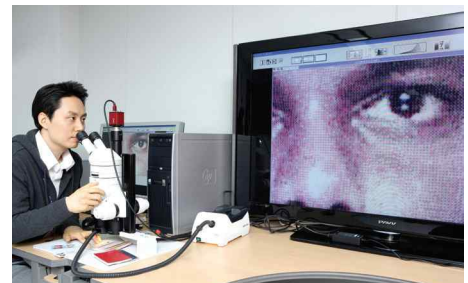
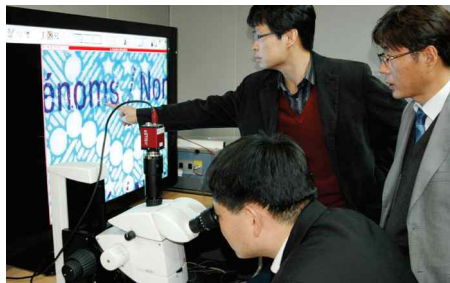

The Institute of Justice teaches skills for criminal investigators, probation officers, and immigration officers to adapt to the ever-changing world.

검찰직, 보호직, 출입국관리직 공무원을 대상으로 한 일반직 교육은 직급별로 기초과정과 심화과정의 단계별 교육으로 체계화되어 있습니다. 강의식 교육방법은 물론 체험식·참여식·사례연구식 등 다양한 교육기법을 가미하여 실질적인 직무역량 강화를 꾀하고 있으며, 인권보호, 부패방지, 규제 개혁 등 정부주요시책을 반영하는 과정을 적극 편성하여 성공적인 국정운영을 뒷받침하고 있습니다.

The General Service Training Program targets investigators and officers affiliated with the Prosecutors' Office, Immigration Service and the Probation Department. This systematic educational program is tailored to meet the needs of the respective trainee's rank. The curriculum offers basic and advanced courses using various effective methods such as: hands-on experiential learning, case studies, and coursework. These methods reinforce, develop and translate into practical job competency for the participants. This training also supports improvement in the administration of state affairs by providing courses that reflect the major policies of the Korean government such as human rights, integrity, corruption prevention and regulatory reform.

연간 약 13만건의 식품, 환경, 보건 등 민생과 밀접하게 관련된 사건을 수사하는 전국 행정부처 및 지방 자치단체 14,000여명의 특별사법경찰에게 형사법, 수사절차, 증거판단 등 이론과 실무를 체계적으로 교육하기 위하여 2009년 특별사법경찰교육센터를 출범하였습니다. 집합교육과 출장교육을 병행하며 특별사법 경찰관이 전문분야에서 높은 수사역량을 발휘할 수 있도록 지원하고 있습니다.

The Special Judicial Police Education Center was established in 2009 to systematically educate the over 14,000 special judicial police officers who are affiliated with nation's Executive Branch. This force investigates approximately 130,000 cases annually that are related to food, environment and general welfare of South Korea. This educational program offers theory and practice in the areas of criminal law, investigative procedures, and evidence-based judgment and case analysis. The Institute of Justice fully supports these officers in order to nurture and develop high quality investigative talents by providing both skills-related courses in the gathering and analysis of evidence.

After the rule of law in South Korea was established in the 1980s, lawsuits against local and state authorities rapidly increased. In 2010, the Institute of Justice founded the National Litigation Education Center to better prepare government officials in their responses to these lawsuits. The Institute of Justice through its educational programs, lectures, and curriculum strives to improve the professionalism and knowledge of the litigation center trainees.



EDUCATIONAL SUPPORT FOR LAW SCHOOLS

The Institute of Justice cultivates the education of law students through educational programs that emphasize legal knowledge and ability.

2009년 한국에 로스쿨제도가 도입되었습니다. 법무연수원에서는 실력과 소양을 겸비한 예비 법조인을 양성하기 위하여 현직검사들을 교수요원으로 양성·파견하여 검찰실무를 강의하도록 지원하고 있습니다. 국민들에게 고품질의 법률서비스를 제공하는 우수한 실무가 양성을 위해 로스쿨 교육지원을 계속 확대해 나갈 계획입니다.

In 2009, the Republic of Korea implemented the law school educational system. Prior to 2009, one could only be admitted to the practice of law by passing the Judicial Examination and completing a two-year training course at the Judicial Research and Training Institute, a national institution.

The Institute of Justice trains law school students by providing current prosecutors to instruct these students regarding the practical affairs of the Korean Prosecution Service. The goal is to nurture and develop these students in order to combine their talents with legal knowledge from these prosecutor-professors. The Institute of Justice will continue to extend support to the law school educational system in order to develop the very best legal officials who in turn will provide the highest quality legal services to the nation.

Starting in 2012, law school graduates became newly-appointed prosecutors. Prior to 2009, one could only become a prosecutor by passing the Judicial Examination with a certain high score and completing a two-year training course at the Judicial Research and Training Institute, a national institution. Considering the fact that these newly-appointed prosecutors have a much shorter legal and practical educational training than the Judicial Research and Training Institute graduates, the Institute of Justice established a separate curriculum for these law school graduates.

By focusing on practical education and public ethics, the Institute of Justice is able to cultivate the skills and leadership needed for these law school graduates to become effective prosecutors.



CYBER TRAINING

인터넷을 이용한 사이버교육은 2000년 최초로 도입한 이래 장비와 시설을 지속적으로 보강하여 연간 170,000명의 수강이 가능한 시스템을 운영하고 있습니다. 최근 교육콘텐츠 고도화 사업을 통해 전담업무, 직렬, 관심분야별로 맞춤형 교과목을 개발하여 현장에서의 실무능력을 높이는 교육생 중심의 시스템을 설계·운영하고 있습니다.

Since the introduction of the Internet-based cyber training in 2000, the Institute of Justice continues to upgrade all of its technology. The cyber training system is capable of handling over 170,000 persons annually. Currently, with the advancement of its educational centers, the Institute of Justice is developing a trainee-centered system which takes advantage of the trainee's skills in the trainee's field by developing customized subject content for each task, position, and area of interest.

1997년부터 개발도상국 및 체제전환국의 법조인과 고위 공직자 등을 국내로 초청하여 경제성장과 함께 민주주의를 달성한 대한민국의 경험과 사법체계를 소개하는 사업을 전개하고 있습니다. 법무연수원에서는 아시아, 아프리카, 중남미, 중앙아시아, CIS국가 등 외국 고위 공무원을 초청하여 우리나라의 우수한 사법체계와 형사사법 운용 경험을 전수하고 있습니다.

앞으로 연수기회를 계속 확대해 나가는 한편 국가별 특성 및 현안을 반영한 연수과정으로 개발·운용함으로써 외국에 우리 법제를 수출하고 G20 일원으로 성장한 대한민국의 국격을 향상시키는데 일익을 담당하고 있습니다.

Since 1997, the Institute of Justice has invited numerous senior legal officials from transitional and developing countries to participate and attend international training courses at the Institute of Justice. These courses introduce the Korean experience and the Korean criminal prosecution system that contributed to the rapid growth of Korea's economy and democracy. Countries from all over the globe in Asia, Africa, Central and South America, and the Commonwealth of Independent States have visited and attended the International Training Course. By extending such training opportunities, the Institute of Justice is able to develop and specialize courses to reflect each participating nation's unique legal issues. Through this global endeavor the Institute of Justice proudly takes the responsibility of improving the image of the Republic of Korea to the world. Presently, Korea has promoted its own legislative system abroad and has become a member of the G20, an international forum for governments and central bank governors from 20 major economies.



INTERNATIONAL EXCHANGE AND COOPERATION

The Institute of Justice reinforces the importance of exchange and cooperation with other foreign legal education institutions.

교육기관간의 교류를 통해 경험을 공유하고 발전방향을 함께 모색하기 위해 1985년 일본 법무총합연구소를 시작으로 2002년 중국 국가검찰관학원, 2010년 프랑스 국립사법관학교와 상호 교류협력에 관한 MOU를 체결하였습니다.

또한 최근 법무연수원에서 중국 국가검찰관학원, 베트남 사법교육원,

터키 법무아카데미, 이집트 국립사법연구소를 방문하고, 일본 법무총합연구소 소장, 프랑스 국립사법관학교장, 중국 국가검찰관학원 당위서기, 베트남 법무부장관이 내방하는 등 외국 법무교육기관과의 교류를 지속적으로 확대해 나가고 있습니다.

The Institute of Justice, through its educational exchanges with other foreign legal institutions, and keeping in mind the goal of sharing its experiences and making a better future, has signed Memorandums of understanding (MOU) with: The Legal Training and Research Institute of Japan [1985], the National Prosecutors College of China [2002], and the French National School for the Judiciary [2010].

Additionally, Institute of Justice officials visited the following foreign legal institutions: the National Prosecutors College of China, the Vietnamese Institute for Judicial Education, the Turkey Legal Research Academy, the Egypt National Institute of Justice, the Legal Training and Research Institute of Japan, the French National School for the Judiciary, the National Prosecutors College of China, and the Ministry of Justice in Vietnam. We strive continuously to expand our exchange network with foreign legal educational institutions all over the world.

Through scholarship exchanges with both internal and external research institutions in Korea (as well as invitations extended to foreign legal personnel as visiting research fellows) and long-term research projects focused on the development of legal issues, the Institute of Justice produces tangible results from high quality research that can be used for the advancement in legal studies in the Prosecution Service. The Institute of Justice also maintains a study abroad program for mid-level prosecutors who attend legal institutions all over the world. These prosecutors learn and study at foreign legal institutions and provide research and reports to assist the Prosecution Service to be more effective in their responsibilities to its citizens.

법무연수원에서는 법무부와 검찰에서 필요로 하는 연구주제를 최우선으로 연구하고 그 결과를 법무부·대검찰청에 제출하여 정책에 반영하고 있습니다. M&A 관련 법제연구서는 일선 검찰에서 금융과 회사 관련 범죄 수사의 바이블로 호평받고 있으며, 매년 발간하는 범죄 통계·분석서인 범죄백서는 형사정책 연구를 위한 기본 데이터로 활용되고 있습니다. 앞으로도 법무부·대검의 정책 결정이나 일선 수사에 실질적으로 활용될 수 있는 고품질의 연구 성과물을 지속적으로 생산해 나갈 계획입니다.

The Institute of Justice researches top-priority and relevant legal topics for the Ministry of Justice and the Prosecution Service. This research is then formulated into policy and submitted to the Ministry of Justice and the Supreme Prosecutors' Office. Studies on the Enactment of the Law related to Mergers and Acquisitions, which received favorable reviews from the Prosecutor's Office and is now considered "The Bible" with regard to criminal investigation of corporate finance laws is an example of the high quality research that the Institute of Justice develops. Additionally, the White Paper on Crime is published annually and the data collected is used to further develop new policy for the Ministry of Justice and the Prosecution Service.

해외연수검사 연구주제 선정 및 논문 심사업무를 2010년에 대검으로부터 이관받아서 수행하고 있습니다. 학술적·실무적으로 연구 가치가 큰 과제를 엄선하여 배정하고, 연수중에도 연구방향을 수시 지도하여 의미있는 결과물이 생산될 수 있도록 지원하고 있습니다. 또한 연수 종료 후에는 법학교수 등 외부 전문가가 포함된 심사위원회에서 논문 평가를 실시하고 우수 논문을 모아 논문집을 발간함으로써 연구결과물의 질적 수준을 제고하고 있습니다.

Since 2010, the Institute of Justice conducts reviews of research theses written by prosecutors studying abroad in order to publish them for the Supreme Prosecutors' Office. The Institute of Justice carefully selects legal topics that have great value in both the academic and practical world. The Institute of Justice frequently provides guidance to assist prosecutors to produce significant and meaningful results in their research and writing. These theses are consistently reviewed by a Review Committee comprised of legal professionals and legal experts. At the end of the international exchange, the Institute of Justice publishes a collection of distinguished theses.

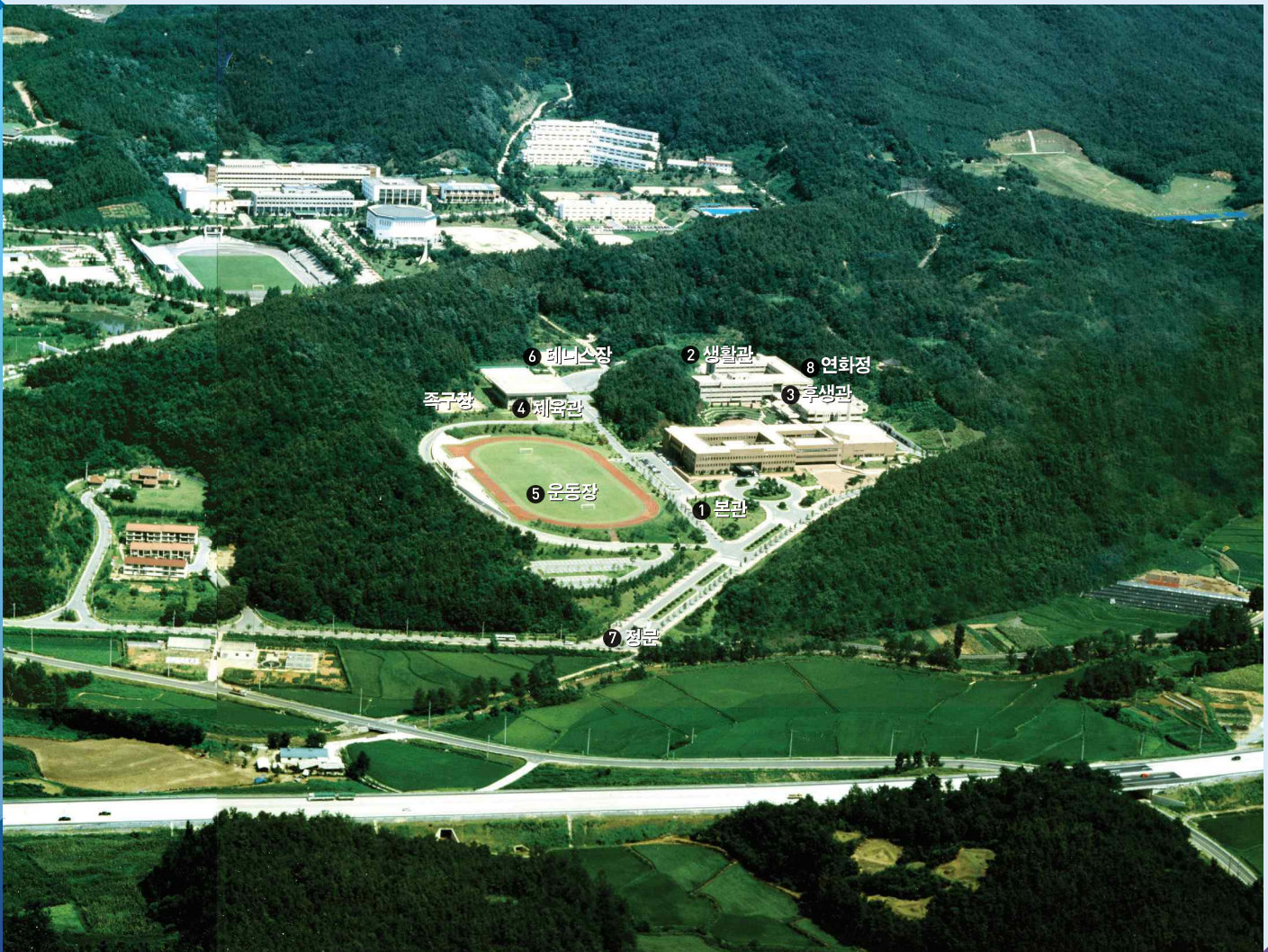
